The Interim Superintendent of Schools recommends, and I so move, adoption of the following:

**RESOLUTION**

The Plainfield Board of Education recognizes that a highly qualified, competent, skilled, and dedicated workforce is essential to the success of the District and the students. Therefore, it has provided the Interim Superintendent of Schools the authority to employ staff members to participate professional development opportunities within our District.

To support student understanding in literacy and mathematics and to build teacher pedagogical knowledge and understanding of reading comprehension, writing, and mathematics the Office of Educational Services will provide three (3) instructional programs for teachers with a stipend of \$28.00 per hour for a total not to exceed nine (9) hours. Facilitators of the instructional programs will receive a stipend of \$28.00 per hour not to exceed eighteen (18) hours (nine hours of instruction and nine hours for preparation).

In keeping with the strategic plan and goals for the district, Cedarbrook K-8 Center's 8<sup>th</sup> Grade will visit New York City to attend a performance of The Lion King on Broadway at the Minskoff Theatre. The performance will increase or provide for the first time, cultural exposure to theatre and the arts. Students will be able to experience professional "live" performances. Upon their return, students will compose an essay of their experience and share with the Cedarbrook community.

In doing so, it is also committed to providing opportunities for and ensuring that all students (inclusive of English Language Learners and Special Education Students) meet the New Jersey Core Curriculum Content Standards and achieve academic and life-long success.

Eighteen (18) eighth grade students and five (5) chaperones from Frederic W. Cook K-8 Center will attend Colonial Williamsburg and Busch Gardens in Williamsburg, Virginia. Students will learn that citizenship is the cornerstone of a republic and that founding fathers learned, discussed, and debated the rights and responsibilities of citizenship in Williamsburg and then created a nation based on these principles.
