**RESOLUTION**

The Plainfield Board of Education is committed to ensuring that all students succeed academically and reach their full potential. In doing so, it is also committed to providing opportunities for and ensuring that all students (inclusive of English Language Learners and Special Education Students) meet the New Jersey Core Curriculum Content Standards.

Ninety (90) students in grades 4-6 participating in the Barlow Elementary School band, chorus, and orchestra and fifteen (15) chaperones will attend and perform at the *High Note Festival* at Hershey Park, Hershey, PA on June 3, 2011. Departure is scheduled for Friday, June 3, 2011 at 7:00 a.m. and returning at 9:00 p.m. The primary objective is to increase the level of performance of students participating in the band, chorus, and orchestra by demonstrating their understanding of the intricate elements of music. Students will perform and be evaluated by a panel.

The Interim Superintendent of Schools recommends, and I so move, adoption of the following:

### **RESOLUTION**

The Plainfield Board of Education is committed to ensuring that all students succeed academically and reach their full potential. In doing so, it is also committed to providing opportunities for and ensuring that all students (inclusive of English Language Learners and Special Education Students) meet the New Jersey Core Curriculum Content Standards.

Fifty-one (51) 6 grade students and five (5) chaperones from Barlow Elementary School will visit Sahara Sam's Oasis Indoor Water Park, West Berlin, NJ on June 17, 2011. The focus of the trip is to understand proper social interaction in a non-restrictive environment. Students will then apply their acquired skills of writing a standards based narrative based on their experiences. It will be a rich and rewarding experience for the students. They will have the pleasure of enjoying the freedom to socialize with their classmates and applying it to the NJCCCS standards. Students will take part in pre-visit activities as well as post-visit activities relating to social studies, science, literacy, and math.

Departure is scheduled from Barlow Elementary School at 8:30 a.m. and returning at 3:30 p.m. Admissions to Sarah Sam's Oasis Indoor Water Park is \$25.00 per student for a total not to exceed \$1,275.00. There is no cost for chaperones. The cost for transportation is \$765.000 and will be funded by Barlow Elementary School. The cost for admissions will be paid by parents.

**RESOLVED**, that the Plainfield Board of Education approves fifty-one (51) 6 grade students and five (5) chaperones from Barlow Elementary School to visit Sahara Sam's Oasis Indoor Water Park on June 17, 2011. The cost for admissions is \$1,275.00 and will be paid by parents and chaperones. The cost for transportation is \$765.00 and will be funded by Barlow Elementary School.
