MINUTES of a **BUSINESS** Meeting of the Board of
Education Held on Tuesday, February 17, 2009

A **BUSINESS** Meeting of the Board of Education of the City of Plainfield was held this day in the Plainfield Board of Education Administration Building, auditorium. Notice had been provided to Board members and to the Courier-News, Star Ledger, Public Library, City Clerk, Comcast Cable Co., Plainfield Police Department, and posted in all Plainfield Public Schools and the District's website. The meeting was called to order at 6:35 p.m. by Mrs. Roslyn Mathis, Confidential Secretary, and the following action took place:

The Plainfield Board of Education returned to the public session of its Business Meeting at 7:30 p.m.

IV. REMARKS FROM THE BOARD PRESIDENT

None.

V. REMARKS FROM THE SUPERINTENDENT

Dr. Gallon thanked the parents and administrative staff for their presence at the meeting.

He introduced Angela Bento who presented Ian Duhart who did a recitation; members of the PHS Honor Chorus, who introduced themselves individually and sang two songs a cappella; and did a power point presentation of student entries for the design of the new curriculum guide cover designating what Plainfield means to them and the winner was Lafayette Dulaney.

Dr. Gallon along with the Plainfield Board of Education members presented a Character Education Award of Perseverance to various students.

Dr. Gallon presented the Superintendent's Circle of Excellence Awards to two staff members, Mr. Aaron Spivey and Mr. David Damon, who carried out their professional responsibilities very diligently in support of the students and staff at Plainfield High School. This was an incident where a weapon was removed from a student.

Dr. Gallon presented Mrs. Rose Davis who, under the leadership of Dr. Garnell Bailey, gave a brief presentation involving our students and mandatory uniform initiatives. There were elementary students present who gave a fashion show wearing the different styles of uniforms.

The next presentation was given by Mr. Eric Jones involving the District-wide Marketing Plan, highlighting the positive media coverage, community engagement, and District website enhancements.

Mrs. Campbell asked that an oversight be corrected and two of the student liaisons, Nia Baskerville and Donna Worrell, be sworn in at the next meeting.

Students from the Plainfield Academy for Academic and Civic Development (PAACD) gave a presentation referencing the renaming of their school to the Barack Obama Academy for Academic and Civic Development. At the conclusion of their presentation, Mr. Cox put a motion on the floor to suspend the agenda and vote on the resolution renaming the PAACD to the Barack Obama Academy for Academic and Civic Development so that the students can be fully engaged in the political process and to witness the results of such vote, seconded by Mr. Estevez. The motion carried, on a roll-call vote, with eight members in favor and none opposed.

I. Barack Obama Academy for Academic & Civic Development

The Superintendent of Schools recommends, moved by Mr. Cox and seconded by Mrs. Campbell, adoption of the following:

RESOLUTION

To Improve the learning and academic performance of all students in PPS.

The Plainfield Board of Education is committed to ensuring that all students succeed academically and reach their full potential in life. In doing so, it is also committed to providing opportunities for and ensuring that all students (inclusive of English Language Learners and Special Education Students) meet the New Jersey Core Curriculum Content Standards and achieve academic and life-long success.

President Obama's years of public service are based around his unwavering belief in the ability to unite people around the world. In the Illinois State Senate, he passed the first major ethics reform in 25 years, cutting taxes for working families, and expanded health care for children and their parents. He was elected the 44th President of the United States on November 4, 2008, and sworn in on January 20, 2009. He is the first African-American President of the United States. The significance of his continuing contributions will be commemorated in the city of Plainfield by renaming Plainfield Academy for Academic and Civic Development.

Students have been identified as requiring innovative, engaging, and targeted strategies to ensure academic and life long success. The establishment of the Barack Obama Academy for Academic & Civic Development seeks to provide an appropriate and differentiated curriculum, and educational experience for at-risk students and struggling learners, as a replacement for the Plainfield Academy for Academic & Civic Development, now therefore be it

RESOLVED, that the Plainfield Board of Education approves the renaming of the Plainfield Academy for Academic & Civic Development to the Barack Obama Academy for Academic & Civic Development as a school serving at-risk students and struggling learners in grades 9-12, and be it

FURTHER RESOLVED, that the Plainfield Board of Education approves fifty (50) students and ten (10) chaperones to travel to Washington, D.C. during the month of May 2009 to further learn about the nation's Capitol and the political process. This cost will not exceed \$6,000.00 and will be charged to account 51FIELDTRIP.

The motion carried, on a roll-call vote, with eight members in favor and none opposed.

Dr. Gallon gave a presentation regarding School Budget Review and Reconciliation.

VI. PRIVILEGE OF THE FLOOR

Marion Duhart spoke about the need for more guidance counselors in the high school. She said there are just three counselors in the high school and she called the Principal last week to discuss the issue. Dr. Bilal spoke to Ms. Duhart before she left the meeting.

Katherine Cardona expressed her appreciation to the Board and the Superintendent regarding recognition of student performances, staff performance on their jobs and their efforts. She also felt it was commendable that most of the agenda deals with Goal 1 and Goal 2 and that's what we're about. Mrs. Cardona also spoke about the appointment of security officers when there have been members non-renewed. She also spoke about the issue regarding nurses.

Dr. Gallon spoke about the schools being impacted based on the allocation of nurses and they did have an opportunity to discuss that last week. The concerns of parents and members of the Board were heard. They have already taken steps of which every school will have their own nurse. That is reflected on a Board agenda item.

Dr. Gallon also spoke about the reference to security officers. PEA was part and parcel of a discussion about security. The condition existed in which security was assigned to a position structure that precluded him or her from working in excess of five hours. To do so would be in violation of the contract. Therefore in collaboration with PEA and staff the determination was made to establish a structure whereby security can be hired and retained at a school site, specifically at the high school. The process was memorialized, advertised, and finalized. These are not new individuals. These are individuals currently serving in those positions.

Connie Jenkins-Buwa expressed a concern regarding Dr. Gallon's School Budget Review and Reconciliation. She said he spoke of a 33 percent reduction in students, but only 16 percent reduction in teachers or instructors. What would happen, would they be considered nonessential staff and if not who are the nonessential staff Dr. Gallon was referring to? If those teachers are tenured, would they be redistributed? She's concerned about what would happen to those instructors who may have been here 20 or 30 years. Her other question concerned class sizes and how they change. If a class size that was reduced began to expand again, is there a process in place to address that issue.

Dr. Gallon replied that the reference to nonessential was to a hiring and purchasing freeze and also addressed her other concerns.

Cheryl Nagle Smiley expressed her concern about the nurses, sharing with the Board an instance where she had a heart attack and didn't know it until she went to her nurse's office.

Several members of the community, as well as school nurses, shared many instances where if a nurse had not been present the situations would have had dire consequences and they also thanked the Board and Dr. Gallon for keeping the nurses there.

Maria Pellum thanked the Board and Dr. Gallon for keeping the nurses and had some concerns about Early Childhood. Dr. Gallon said Mrs. Belin-Pyles was present at the meeting and could probably speak to her about some of the issues and he would provide answers to her at a later date that she wasn't able

to receive this evening.

Sue Stein read a letter from the mother of a student regarding school nurses.

Dr. Gallon was asked with 1,700 students in the high school, would it be possible to have two nurses there. Dr. Gallon said it is their intent to restore an extra nurse at the high school as well as make provisions for all of our schools. They are trying to provide coverage.

Several Board members shared information regarding family members and the need to have the nurses in the school as well as the impact on the District and the community as a whole with the closing of Muhlenberg Hospital.

VII. REMARKS FROM THE STUDENT LIAISONS

Nia Baskerville, Alisa France and Donna Worrell reported that the PHS Chorus will have an event this month; the New Horizons College Club meets every Wednesday at Washington School from 7:30 p.m. to 9 p.m.; Plainfield High School now has the PHS Senior Scholarship Bulletin which is known as Clearinghouse – there are different scholarships in a booklet seniors can receive from their guidance counselors and the applications are on line and there is an AKA scholarship that is now out for seniors.

Mr. Cathcart added that PHS won a track State championship this week. Also the boys and the girls' basketball teams are in the Union County tournament; both are seated number two, they moved onto the qualifying rounds and tomorrow the boys play in the quarter finals and the girls play on Thursday night. The liaisons added that was the first time since 1982. Mr. Cathcart said that Chanel Johnson was named player of the week in the Courier News.

Ms. Rivers moved, seconded by Mr. Estevez and unanimously approved by the Board, to return to executive session at 10:25 p.m. to discuss legal matters.

Ms. Rivers moved, seconded by Mr. Cox and unanimously approved by the Board, to return to the public session of the meeting at 11:40 p.m.

VIII. REMARKS FROM COMMITTEE CHAIRPERSONS

Ms. Barksdale shared that a PHS 10th grade student was recognized in the National Boxing Competition.

Parents Academy and Gang Symposium were well received.

IX. REPORT OF DELEGATES/LEGISLATIVE REPORT

Ms. Barksdale attended the Urban Boards meeting, the State of Urban Education and Assemblyman Joseph Cryan was there who heads State Education Committee, and the Assemblyman invited boards to send him information if they had concerns. Ms. Barksdale also shared detailed information regarding other meetings that she has attended.

Mrs. Campbell asked that enrollment data figures continue to be provided to the Board. Dr. Gallon responded that he will make sure that continues on a monthly basis to be included in their packets.

Mr. Cathcart read a letter regarding two PHS students (Chanel Johnson and Gazelle last name unknown) being chosen to go to Africa and their need to raise \$1,250 each. They are appealing to the Board for assistance and support in raising this money.

Mrs. Logan-Leach provided information regarding a fundraiser for the Tsunami Track Club on Saturday called the Men Who Cook to be held at Stone Square Lodge from 12 noon to 5:00 p.m.; the cost is \$20.00.

Mr. Cox stated that we lost a great Plainfield citizen Mr. Joe "Spanky" Stevenson who passed away after a long illness, and apologized for not asking for a moment of silence earlier.

XI. REPORT OF THE HUMAN RESOURCES COMMITTEE

“The Board of Education of the City of Plainfield reaffirms its commitment to ensure that the district provides equal employment opportunities regardless of race, color, creed, religion, sex, age, ancestry, national origin, handicap and social or economic status...”

It is the policy of this district to provide, through a positive and effective affirmative action program equal opportunities for employment, retention, and advancement of all people.

Under discussion, Mr. Abdul-Haqq placed a statement that under item A, he understands the reason for these appointments is to increase the hours the hourly securities can work, but he feels it would more appropriate to bring back the non-renewed security employees. The motion carried, on a roll-call vote, with four members in favor of all, Mr. Abdul-Haqq and Mrs. Campbell in favor of all, but opposed to item A; Mrs. Logan-Leach in favor of all, but opposed to items A, D, and X; and Mr. Cox in favor of all, but abstained on Crystal Cox and Natasha Cox.

The objective is to pilot two Performance-Based Assessment Systems in eight kindergarten classrooms (at least two classrooms in 4 elementary schools) four kindergarten teachers will use The Work Sampling System and the other four will use the Child Observation Record System. One of the classes will be a bilingual class and one special education. Staff Development and support will be provided by each company. The cost of each pilot is a follows:

Work Sampling System -\$5,500 for 2 day training-subscriptions at \$13.95 (discount from \$19.95) – for 100 students would = \$1,395-4 classroom kits (@\$99 a kit – gratis.-2 one hour webinars @\$250 each hour (after training) – gratis. This agreement is for consulting services to be provided by BTU Consultants, LLC (BTU) to assist **Plainfield Public Schools** (the Client) with the tasks required for defining and submitting an application to the Federal Communications Commission (FCC), Universal Service Administrative Company (USAC), Schools and Libraries Division (SLD) for the Priority One (Telecommunications and Internet Access) services as part of the E-rate program for the **2009 – 2010 School Year**.

BTU is committed to safeguarding the privacy of information collected from Client and shall maintain the confidentiality of such information. BTU will not sell or rent to anyone the private information entrusted to us. BTU will retain all paperwork for Client for five years per FCC regulations.

BTU and the Client shall discuss and agree upon the information needed for rendering of services. The Client agrees to provide to BTU all such information as agreed to be necessary. With respect to such information, the Client understands and agrees that BTU will rely solely upon the Client to ensure the accuracy and completeness thereof, as the Client recognizes that it is impossible for BTU to ensure the accuracy and completeness of such information. Further, BTU will not be responsible for knowledge of or compliance with local or state procurement laws. As a consultant hereunder, BTU will not be reviewing vendor RFPs or recommending vendors and any vendor selections will be the sole responsibility of the Client.

Phase I – Form 470: Based on the Client's input, BTU shall prepare a FCC Form 470 for the Client's signature and shall review the form with the Client to answer any questions. This form notifies the SLD of the Client's intention to file specific requests within the upcoming funding year. The current estimated date for filing of the Form 470 is October - December 2008.

Phase II – Form 471: BTU shall work with the Client to gather all required information on current local, long distance, cellular and other eligible Telecommunications and Internet costs. BTU shall prepare an FCC Form 471 for the Client's signature and shall review the form with the client to answer any questions. This form represents the Client's specific funding requests for the upcoming funding year. The current estimated date for filing of the Form 471 is December 2008 - February 2009.

Phase III – Form 486: Once the SLD notifies Client of funding approvals, BTU shall prepare an FCC Form 486 for the Client's signature and shall review the form with the Client to answer any questions. This form notifies the SLD that the Client's services have started and of the Client's intention to accept the funds. The current estimated date for filing of the Form 486 is June - September 2009.

Phase IV – Receipt of discounts and Form 472 Billed Entity Applicant Reimbursement (BEAR): BTU shall monitor the Client's awarded funds and assist in recouping all eligible discount amounts. BTU shall prepare all necessary BEAR forms or apply for discounts with all service providers for the current funding year.
