The Plainfield Board of Education is committed to ensuring that all students succeed academically and reach their full potential in life. In doing so, it is also committed to providing opportunities for and ensuring that all students (inclusive of English Language Learners and Special Education Students) meet the New Jersey Core Curriculum Content Standards and achieve academic and life-long success.

Four hundred and fifty-nine (459) K-6 students at Cedarbrook School, twenty-five (25) grade 6 students from Hubbard Middle School, and forty-nine (49) chaperones will participate in an *Introduction to Ocean Habitats* at the Liberty Science Center. Students will define the concept of habitat through interactive activities and exhibits. The lesson will utilize a series of panoramas of an ocean, coastal, and upland habitat zones, to be populated with select species.

Admission to Liberty Science Center is free for all Plainfield Public Schools students. Departure is scheduled for 8:15 a.m. and a return of 1:00 p.m.

Thirty-six (36) students and four (4) chaperones from F.W. Cook School will attend a field trip to the Plainfield Municipal Court. The purpose of the field trip to the Plainfield Municipal Court located in Plainfield, New Jersey, is to provide student knowledge in history, geography, civics, and economics activities. Plainfield students will interact with students from other county school districts. Students will complete a follow-up lesson by including notes and documented stories and artifacts in student portfolios.

RESOLVED, that the Board of Education approves thirty-six (36) students and four (4) chaperones from F.W. Cook School to visit the Municipal Court house on Tuesday, January 27, 2009 from 8:15 a. m. to 12:15 p.m. The district will provide transportation. 3. Montclair State University

The Plainfield Board of Education is committed to ensuring that all students succeed academically and reach their full potential in life. In doing so, it is also committed to providing opportunities for and ensuring that all students (inclusive of English Language Learners and Special Education Students) meet the New Jersey Core Curriculum Content Standards and achieve academic and life-long success.

Forty-nine (49) students and five (5) chaperones from F.W. Cook School will attend a field trip to the Memorial Auditorium at Montclair State University located in Montclair, New Jersey. The purpose of this trip is for students to view the play, "The Color of Justice." This will provide students an opportunity to learn about the "separate but equal" doctrine and its effects on the educational system in the United States of America. The

play emphasizes the events that led to this doctrine as it follows Thurgood Marshall's struggle against school segregation.

Students will observe how geography and social status influence our society, explore how communities are established, and how governmental organizations help keep communities safe. The students will complete a follow-up lesson and activity by creating a Venn diagram, comparing past and present educational systems, and debating opinions about the effectiveness of the current school system.

RESOLVED, that the Board of Education approves Forty-nine (49) students, (inclusive of Special Needs Students and English Language Learners) and five (5) chaperones from F.W. A certified first aid trainer from the American Red Cross will provide training in first aid and CPR for infants and toddlers to Brooke Vuono, Master Teacher; Betty Howell, Childcare Worker; Jodi Byers, Childcare Worker; Guadalupe Hunter-Mercado, Childcare Worker; and Priscilla Aquino, Social Worker. The training will take place on Friday, February 13, 2009, during the staff development day.

The Board has determined that the current tax-exempt interest rate environment may enable it to realize going-forward debt service savings for the taxpayers of the City of Plainfield through the issuance by the Board of refunding school bonds (the "Refunding Bonds") to currently refund all or a portion of the \$29,415,000 outstanding 1999 Refunding Bonds.

In efforts to realize such taxpayer savings, the Board now desires to adopt a refunding school bond ordinance (the "Refunding Bond Ordinance") authorizing the issuance of the Refunding Bonds in an aggregate principal amount of not exceeding \$29,750,000, the net proceeds of which shall be used to refund all or a portion of the 1999 Refunding Bonds.

Also, in accordance with the requirements of Sections 18A:24-61 through 62 of the Education Law, the Board has determined to make application (the "Application") to the Local Finance Board within the Division of Local Government Services, New Jersey Department of Community Affairs (the "LFB") for approval to adopt the Refunding Bond Ordinance and to issue the Refunding Bonds (collectively, the "Refinancing"); and the Board believes that:

- (a) it is in the public interest to accomplish the Refinancing;
- (b) The Refinancing is for the health, wealth, convenience or betterment of the inhabitants of the City of Plainfield;
- (c) the amounts to be expended for the Refinancing are not unreasonable or exorbitant;
- (d) the Refinancing is an efficient and feasible means of reducing the costs of providing services for the needs of the inhabitants of the City of Plainfield and will not create an undue financial burden to be placed upon the City of Plainfield.

RESOLVED BY THE BOARD OF EDUCATION OF CITY OF PLAINFIELD, IN THE COUNTY OF UNION, STATE OF NEW JERSEY as follows:

Section 1. The preparation of the Refinancing Application and the filing of same with the LFB for its approval is hereby approved, and the School Administration, together with Wilentz, Goldman & Spitzer, P.A. bond counsel, Lerch Vinci & Higgins, auditor and Phoenix Advisors, LLC financial advisor are each hereby authorized and directed to represent the Board in such matters pertaining thereto.

Section 2. The LFB is hereby respectfully requested to consider the Refinancing Application and to record its findings, recommendations and/or approvals as provided by the applicable provisions of Sections 18A:24-61 through 62 of the Education Law.

Section 3 The Refunding Bond Ordinance attached hereto as Exhibit A is hereby approved. Bond Counsel on behalf of the Board is hereby authorized to publish the required notice of adoption of the Refunding Bond Ordinance in The Courier News, in the form and at the time required by Section 18A:24-61.4 of the Education Law.

Section 4. This resolution shall take effect immediately.

REFUNDING SCHOOL BOND ORDINANCE PROVIDING FOR THE REFUNDING OF ALL OR A PORTION OF THE OUTSTANDING PRINCIPAL AMOUNT OF 1999 REFUNDING SCHOOL BONDS OF THE BOARD OF EDUCATION OF THE CITY OF PLAINFIELD IN THE COUNTY OF UNION, STATE OF NEW JERSEY, AND AUTHORIZING THE ISSUANCE OF NOT EXCEEDING \$29,750,000 PRINCIPAL AMOUNT OF REFUNDING SCHOOL BONDS OF THE BOARD OF EDUCATION TO EFFECT SUCH REFUNDING

WHEREAS, The Board of Education of the City of Plainfield in the County of Union, State of New Jersey (the "Board" when referring to the governing body and the "School District" when referring to the territorial boundaries governed by the Board) issued \$31,120,000 School Refunding Bonds on April 9, 1999 (the "1999 Refunding Bonds") in order to advance refund its outstanding \$33,900,000 school bond dated April 15, 1997 issued to the Union County Improvement Authority for the purpose of financing district-wide school improvements;

WHEREAS, the Board has determined that the current tax-exempt interest rate environment may enable it to realize going-forward debt service savings for the taxpayers of the City of Plainfield through the issuance by the Board of refunding school bonds (the "Refunding Bonds") to currently refund all or a portion of the \$29,415,000 outstanding 1999 Refunding Bonds; and

WHEREAS, in efforts to realize such taxpayer savings, the Board now desires to adopt a refunding school bond ordinance (the "Refunding Bond Ordinance") authorizing the issuance of the Refunding Bonds in an aggregate principal amount of not exceeding \$29,750,000, the net proceeds of which shall be used to refund all or a portion of the 1999 Refunding Bonds; and

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF EDUCATION OF THE CITY OF PLAINFIELD IN THE COUNTY OF UNION, STATE OF NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. The Board is hereby authorized to refund all or a portion of the \$29,415,000 outstanding 1999 Refunding Bonds maturing on or after August 1, 2010. The 1999 Refunding Bonds maturing on or after August 1, 2010 may be redeemed on or after August 1, 2009, upon no more than 60 days and no less than the 30 days notice from the date the 1999 Refunding Bonds will be called (the "Redemption Date") at the redemption price of one hundred percent (100) of par plus accrued interest to the Redemption Date.

Section 2. In order to provide funds necessary to effect the refunding of all or a portion of the 1999 Refunding Bonds, the Board is hereby authorized to issue not exceeding \$29,750,000 aggregate principal amount of Refunding Bonds, all in accordance with the requirements of Sections 18A:24-61 through 62 of the Education Law.

Section 3. An aggregate amount not exceeding \$552,000 (including a bond issuance premium in the approximate amount of \$212,000) may be allocated from the aggregate principal amount of the Refunding Bonds to pay for the aggregate costs of issuance thereof, including underwriting, printing, advertising, accounting, financial, legal and other expenses in connection therewith.

Section 4. The purpose of the issuance of the Refunding Bonds is to realize a going-forward net interest cost savings for the Board.

Section 5. A certified copy of this Refunding Bond Ordinance as adopted on first reading has been filed with the Director of the Division of Local Government Services in the New Jersey Department of Community Affairs prior to final adoption hereof, together with a complete statement in the form prescribed by such Director and signed by the Board Secretary, as chief financial officer of the Board, as to the School Bonds to be refinanced by the issuance of the Refunding Bonds authorized herein.

Section 6. The supplemental debt statement required by N.J.S.A. 18A:24-16 and N.J.S.A. 18A:24-61.4 has been duly prepared and filed in the Office of the Clerk of the City of Plainfield and in the Office of the Business Administrator/Board Secretary of the Board as of the date of approval of this Refunding Bond Ordinance and a complete executed duplicate of same has been filed in the Office of the Director and such statement shows that the gross debt of the Board is increased by the authorization of the Refunding School Bonds by \$1,395,000.

Section 7. The Board covenants to maintain the exclusion from gross income under Section 103(a) of the Internal Revenue Code of 1986, as amended, of the interest on all bonds and notes issued under this Refunding Bond Ordinance.

Section 8. This Refunding Bond Ordinance shall take effect upon final adoption hereof, after the consent of the Local Finance Board has been endorsed upon a certified copy hereof.
