IV. REMARKS FROM THE BOARD PRESIDENT

Mrs. Logan-Leach indicated the senior's scholarship program was recently held. A surprise scholarship will be awarded on June 10, 2010 in the amount of \$40,000 to a PHS student by the Ronald McDonald Foundation.

The District science fair was held on June 7, 2010. The Family Success Center will hold an open house on June 12, 2010.

The 21 Century held their end of year showcase event tonight.

V. REMARKS FROM THE INTERIM SUPERINTENDENT

One June 10, 2010 the board will co-sponsor with the City a forum on gang violence at PHS. Mrs. Belin-Pyles reviewed the various summer programs that will be offered this year.

She also indicated that Caryn Cooper has been appointed Interim Assistant Superintendent for Educational Services.

We also have appointed Yvonne Breauxsaus as acting principal at Barlow School.

Mrs. Campbell participated in career day at Woodland School as well as at Hubbard and Emerson. The science fair was also very impressive.

Mrs. Hernandez was at field day at Hub Stine. She also received a phone call from "Angels in Action" which was resolved.

Mr. Abdul-Haqq has been speaking with Dr. Bilal and Ms. Hembree about an after school culinary program. Also, because of the size of PHS, he doesn't feel that he can be a liaison to Evergreen School.

Ms. Barksdale doesn't have a report but she encouraged students to be well rested and ready for their final exams.

Mrs. Logan-Leach indicated that a community person suggested that student liaisons be able to ask questions on agenda items. Perhaps this can be a discussion item at the board retreat.

She also requested for Sodexo to give an update on food services in the district on June 22, 1010.

The Board moved C & I and Finance to the business meeting.
