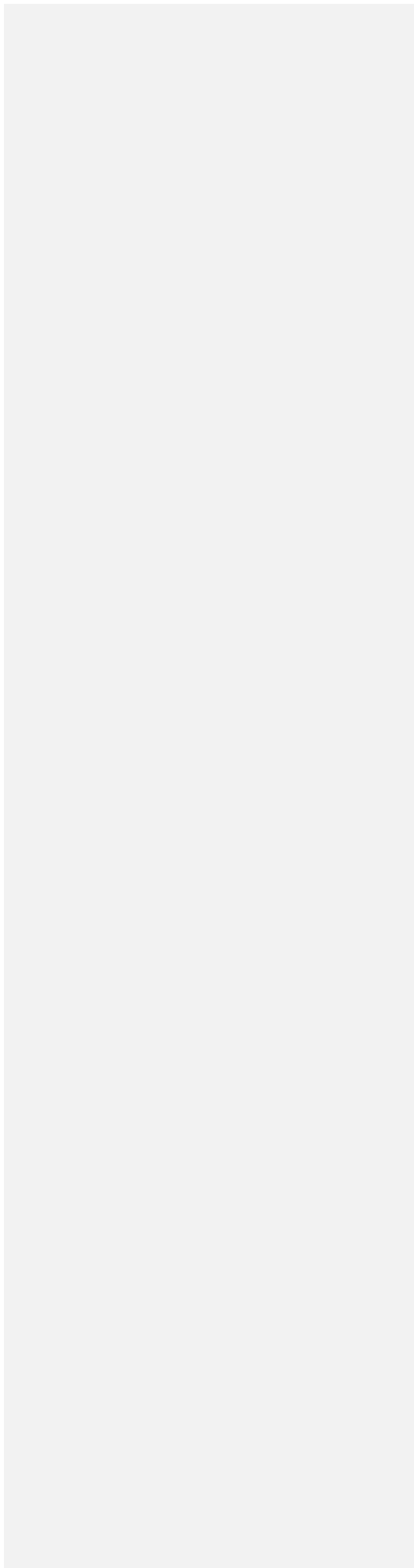

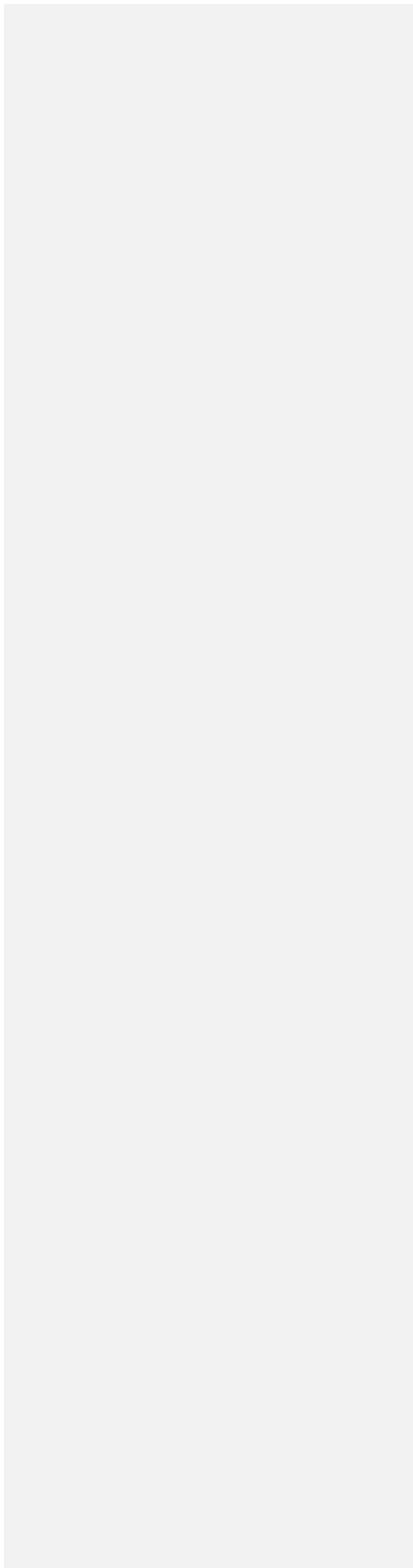

The Plainfield Board of Education is committed to ensuring that all students are academically successful and reach their full potentials. In doing so, it is also committed to providing opportunities for and ensuring that all students meet the New Jersey Core Curriculum Content Standards for optimal academic achievement and life-long success.

The fourth and fifth grade classes at Jefferson Elementary School comprised of 125 students will visit the American Museum of Natural History in New York City on June 5, 2012. Departure is scheduled at 8:30 a.m. and return at 4:30 pm. Upon arrival, we will tour different parts of the museum. Then has a group will attend the planetarium and then work has a group to answer questions based on different exhibits provided while touring the museum. Groups will have to work together to complete the scavenger hunt worksheets. Students will be given the opportunity to connect science concepts with to the various visual learning styles of students to keep them engaged. These experiences will reinforce learning in the NJCCCS.

The Alliance for Competitive Energy Services is an alliance composed of the New Jersey School Boards Association, the New Jersey Association of School Administrators, and the New Jersey Association of School Business Administrators.

From time to time during the effective period, ACES will solicit bids from electric power suppliers for electric generation services through an energy aggregation program in which NJSBA will act as the Lead Agency of the ACES Cooperative Pricing System #E8801-ACESCPS.

The Plainfield Board of Education has participated in the ACES program for many years and wishes to continue its participation, now therefore be it
